Please submit **your completed form** to the MTRS in one of three ways:

- 1) **FAX** to 617-679-6842 (be sure to also fax a photocopy of death certificate); or
- 2) **MAIL** to MTRS Retiree Services, 500 Rutherford Ave., Suite 210, Charlestown, MA 02129 (be sure to mail a photocopy of death certificate); or,
- 3) **E-MAIL** to RetServUnit@trb.state.ma.us (see instructions below).

EINs are issued by the Internal Revenue Service (IRS), and obtaining one is fast, free, easy and can be done online.
